41ST ANNUAL GENERAL BODY MEETING

41st Annual General Meeting of the Branch was held on January 4, 2020. The AGM was attended by 54 members and the new office bearers for the period 2020 – 2022 were also elected. The Executive Committee for the period 2020 – 2022 was also nominated. Shri B.R. Sharma, IAS (Retd.) was re-elected as Chairman of the IIPA, JK Regional Branch and Dr. Ashok Bhan, IPS (Retd.), Former DGP, J&K Police was nominated as Patron for the Branch (Refer Page 8 for details). Dr S.S. Bloeria, IAS (Retd.) former Patron and Chairman of IIPA, JK Regional Branch also addressed during the AGM. The key highlights of the AGM are:

- The branch should develop Vision 2025 and lay emphasis on quality output in form of policy reports, research projects, training programme, seminars and panel discussions.
- Joint projects in collaboration with academic institutions should be planned.
- Branch is committed to establish itself as a Centre for Excellence in public administration and management by taking up research projects having public policy implications.
- A detailed expansion plan of the existing infrastructure proposed by Executive Committee was approved by AGM. As per the plan, the extension will be undertaken in two phases. J&K Police Housing Corporation shall be approached for executing the approved plan.



- Access to collateral free credit, equity infusion through "funds of funds", and subordinate debt for stressed MSME in the recently announced stimulus package, if leveraged effectively, can help MSME to not only to reboot themselves from the COVID-19 crisis, but will also facilitate them to scale up their operations to be globally competitive.
- The decisions taken by Central Government to support MSMEs will help the stakeholders to reduce their overdependence upon debt by leveraging Rs 50,000 crore equity infusion

- scheme which will give them access to the funds of venture capital firms.
- Competitive MSMEs can even explore the opportunity to get listed on stock exchanges.
- Technology will be a great differentiator and access to technology will be the key to become globally competitive.
- Reforms in procurement policy can help local manufacturers to be competitive and that all stakeholders should adopt the TReDS platform, be vocal on MSME Samadhan Portal and activate the MSME Facilitation Council at the UT level.
- J&K Bank being the lead bank in UT of J&K will play a proactive role by facilitating all the MSME's with access to credit as outlined in the guidelines of the stimulus package.
- Government to support MSME, should receive adequate support by the state governments and the bankers, by creating an environment of mutual trust.

 Citizens should be proactive and should always decontextualize the news before evaluation, as it has a potential to influence their minds and emotions.

- There is a greater need for value driven and ethical based journalism to curb the menace of fake news.
- The strength of a robust democracy lies in the independence of its media and fake news poses a greater challenge to the society, especially with the advent of technology.
- Fake news has a potential to create hatred, disturb democratic processes, generate violence and even lead to war between nations. The power of fake news to generate societal tensions is a concern for government as well as society.
- Media fraternity should guard itself from becoming the propagators of fake news and adopt ethical code of conduct while fulfilling their responsibility as the fourth estate of democracy.

A Panel Discussion on "Cyber Security" was organized on July 11, 2020. The panelist included Sh S K Bhalla, Director (Cyber & Information Security Cell), Ministry of Home Affairs, Government of India and Mr. Amit Dubey, a renowned National Security Expert and Crime Investigator from New Delhi and was chaired by Dr. Ashok Bhan, IPS (Retd), Former DGP, J&K Police. Sh. B.R Sharma, IAS (Retd), Chairman, PSC and Chairman, IIPA presided over the function. The key highlights of the Panel Discussion included


- Individual privacy in the networked boundary-less world is a utopian thought and therefore cyber safety and security is essential.
- Information can play a vital role in the investigation of cyber crimes.
- More than 60% of the cyber crimes in the country correspond to financial frauds and the intensity of such crimes have increased during COVID-19 outbreak.
- Central Government through the Cyber Division of MHA has proactively taken a number of policy initiatives in protecting the citizens from potential threat of cyber crimes.
- The National Cyber Crime Reporting Portal (www.cybercrime.gov.in) is an initiative of the government to register digital FIR with special focus on cyber crimes against women and children.
- Further efforts are being made to strengthen National Cyber Crime Forensic Lab to investigate and prevent complex cyber crimes.
- Various initiatives like Indian Cyber Crime

- Coordination Centre (I4C) scheme, National Cyber Crime Research and Innovation Centre have been established to create strategic partnerships with all institutions which can help in cyber crime containment and investigations.
- It was proposed that the Government can create a national level database of cyber criminals and their activities should be tracked using high end technological solutions for proactive response
- Various international and national level case studies were presented which exhibited how companies are capturing the data of people across the world which is a two edged-sword and can be leveraged by the companies.
- Dgital capabilities of individuals, institutions and government agencies should be enhanced to prevent vulnerabilities.
- The proposed Personal Data and Protection Bill, 2019 will emerge as a legal framework for data protection in India.

The panel discussion was attended by the participants from Puducherry, Odisha, Maharashtra, UP, MP, Gujarat and Bihar. Also international participants from USA and Singapore also joined the Webinar.

The expert comments were made by Prof R D Sharma, Former Vice-Chancellor University of Jammu; Prof Ashok Aima, Vice-Chancellor, Central University of Jammu and Prof Manoj Dhar, Vice-Chancellor University of Jammu. Sh. B R Sharma, IAS (Retd), Chairman, IIPA JK Branch presided over the function. The key highlights during the webinar were

- COVID-19 has given a tremendous opportunity to the education sector to reinvent, reorganize and reform itself in terms of pedagogy, examination and extension activities.
- In light of the Digital India initiative, many Universities and other educational institutions can leverage technological platforms to provide 24x7 teaching learning processes.
- There is a tremendous need to build the technological capacities of the teachers and the institutions especially in the semi-urban and rural areas in order to bridge the digital divide.
- There is an urgent need to explore and possibilities of sustainable reforms in the examination and evaluation processes which can go beyond the pandemic.
- The institutions should invest in building the technological infrastructure which can meet the needs of the teachers, scholars and students even in the future.
- Government should create digital platforms through which synergies can be created by the sharing of resources, best practices and infrastructure.
- In J&K under the Sarv Shiksha Abhiyan, prior to pandemic, a number of initiatives have already been taken through JK Knowledge Network. This will surely help the school students in the backward areas to get access to global knowledge and help them to become globally competitive

PANEL DISCUSSION ON NATIONAL EDUCATIONAL POLICY-2020



- NEP will enable India to achieve global education development agenda reflected in the Goal 4 (SDG4) of the 2030 Agenda for Sustainable Development.
- NEP lays emphasis on competency mastery instead of content mastery which if implemented effectively will enable to youth to become more

productive in the interest of the nation.


- NCERT is working towards creation of new curriculum framework which will transform the way the knowledge is transmitted to the children.
- Critical and innovative thinking among children should be encouraged so that they construct their own knowledge based on experiential learning.
- Concept of Self-Assessments, emotional wellbeing aspects, personality development and inculcation of concepts of arts, culture and sports should be incorporated into curriculum.
- Government of Jammu & Kashmir is committed for effective implementation of NEP 2020 by creating appropriate structural and procedural reforms by involving all the relevant stakeholders including higher education.
- Around 600+ Vocational Laboratories, focusing more on Inclusiveness and ICT based pedagogy in schools is being planned in UT of J&K.
- Skilling and re-skilling of existing teachers for holistic development of teachers is also critical for effective implementation of the policy.

Sh. K B Jandial, Director (Seminars), presented the welcome address. Prof. Alka Sharma, Secretary presented the formal vote of thanks. Dr. Anil Gupta, Joint Secretary, and Dr. Ravinder Jangral, Samagra Shiksha coordinated the programme. The session was attended by around 150 participants including all the Chief Education Officers, Principals and HoDs of DIETs, Private School representatives, teachers, members of IIPA and civil society.

WEBINAR ON "MANAGING STRESS AND COPING WITH COVID 19"

A webinar on "Managing Stress and Coping with Covid 19" on May 19, 2020. Dr. Jaipal Singh, ex HOD and Professor of Medicine, GMC Jammu; a Reiki Grandmaster, pranic healer and a life-style counsellor was the key note speaker. The key highlights of his talk were

- It is important to differentiate between concern and fear while dealing with Covid-19.
- Explain the science behind the stress; he informed
 the participants that when our body is stressed, the
 sympathetic nervous system contributes to what is
 known as the "fight or flight" response whereas the
 parasympathetic nervous system plays a vital role
 in helping the body to calm down from stress
 reactions.
- He urged the participants to follow both general and specific rules – regular exercise, balanced diet, sound sleep, inculcate hobby, positive approach, mindful meditation and yoga which can help to build immunity and manage stress in times of crisis.

The session was followed by a lively interactive session, wherein a number of queries were raised by the participants to clear their doubts about the present uncertain situation. PRELUDE CONFERENCE ON "MANAGEMENT OF PANDEMICS"

A prelude conference on "Management of Pandemics" was organized on October 23, 2020. Dr Pawan Kotwal (IAS), Principal Secretary, Revenue, Government of Jammu & Kashmir and also Administrative Coordinator for all nontreatment issues at Hospitals; Dr. Yashpal Sharma, Managing Director, J&K Medical Supplies Corporation Limited and Director (Coordination), New Medical Colleges, J&K; and Dr. Arun Sharma, Medical Superintendent Super Specialty Hospital & (Maternity) Designated COVID Hospital Gandhinagar, Govt Medical College Jammu were the key resource persons. The key highlights of the deliberations are


- Doctors and other staff in a span of 6-8 months have learned exponentially about the various challenges and strategies to combat the pandemic.
- Government of UT of Jammu & Kashmir has taken adequate measures to improve the health infrastructure & facilities across various hospitals across the UT to combat this pandemic. The improved facility will go a long way in future management of patients and such disasters.
- Despite various challenges faced during the initial period, the health care infrastructure for management of COVID patients / suspects has improved by establishing 22,644 Isolation beds, 442 ICU beds and 5553 Oxygen supported beds in Category-I, II & III hospitals / COVID Care Centres.
- Besides this, 1,053 Ventilators were also provided to the health care institutions out of which 850 ventilators were provided under PM CARES. He informed that as on date, the bed occupancy is 23% and 33% in Jammu Division and Kashmir Division respectively in Tertiary Care Hospitals indicating that the UT has enough facility to combat the pandemic.
- Government has sanctioned Oxygen generation plants, Manifolds and medical gas pipelines for all associated hospitals of GMCs (Old & New), with the financial implication of Rs. 212 Cr., 30 CHC / District Hospitals (15 each in Kashmir & Jammu Divisions), are being provided with Manifold and Gas Pipeline System under World Bank funded project with financial implication of Rs. 60 Cr. Liquid Oxygen Tank with financial implication of

Rs. 11 Cr has also been sanctioned for Govt. Medical College Hospital Jammu to overcome the crisis of Oxygen shortage.

Sh. K B Jandial, IAS (Retd), Director (Seminars) presented the welcome address. Prof. Alka Sharma, Hony Secretary conducted the proceedings and Sh Vikrant Kuthiala, Hony Treasurer presented the formal vote of thanks.


